Eligibility Criteria for Fee Waivers. To be considered for the application fee waiver, you must be: An undergraduate student (you cannot be in an extension program) A California resident for more than one year; A U.S. citizen or someone without lawful immigration status who qualifies for an AB540 non-resident tuition exception; Applicants who are eligible for the application fee waiver may apply to up to four CSU campuses per application term (i.e., fall, spring).

Excluded from the fee waiver program are self-supported programs such as Extended Education. A maximum of 2 courses or 6 units per term, whichever is greater, may be taken under the fee waiver program. Fee Policies and Process | CSU

All students enrolled at a CSU campus pay a systemwide tuition fee, in addition to campus mandatory fees. The CSU makes every effort to keep student costs to a minimum.

Tuition & Fees | CSU

The eligibility guidelines are much the same as they are for SAT and ACT fee waivers, with the most common being a certain yearly family income and/or being part of the Federal Free or Reduced Lunch program. If you already got a testing fee waiver, then your counselor can approve your college app request without any further input from you.

How to Get a College Application Fee Waiver: 3 Approaches

Courses in self-support (i.e., Extended Education) programs may not be taken through the CSU Fee Waiver program. Unit Limitation : All eligible non-represented and represented employees may enroll in a maximum of two (2) courses or six (6) units, whichever is greater, per term, excluding the CSU Doctoral Programs.

Fee Waiver - California State University, Fresno

The California State University (CSU) Fee Waiver and Reduction Program (Fee Waiver) provides eligible CSU employees with the opportunity to enroll in work-related courses necessary for improving skills applicable to existing employment with the CSU or necessary for advancement in the CSU in accordance with an approved individual career development plan as a career employee in the CSU.

College Fee Waiver The College Fee Waiver for Veteran Dependents benefit waives mandatory system-wide tuition and fees at any State of California Community College, California State University, or University of California campus. This program does not cover the expense of books, parking or room and board.

CalVet Veteran Services College Fee Waiver

Employee Fee Waiver Guidelines. Fees are waived for a maximum of two (2) classes, or 6 units, whichever is greater. Exceptions to this limitation are made for employees on leave.. If the unit/course limitation is exceeded, the employee must pay the difference in fees.

Fee Waiver Program - California State University, Long Beach

FEE WAIVER PROGRAM. The Tuition Fee Waiver Program, established in 1975, provides eligible California State University employees the opportunity to attend classes at CSU campuses at reduced rates. The authority to administer the program is based on Executive Order No. 491, supplemental policies issued by the Office of the Chancellor, and collective bargaining agreements.

Fee Waiver Program | California State University, Bakersfield

Effective with the Spring 2020 semester, completed Fee Waiver applications must be submitted to the CSUF Benefits Office before the official start date of the semester. Approved applications submitted after the start of the semester must be appealed to and approved by Student Business Services.

Employee Fee Waiver - Student Business Services | CSUF

Eligible faculty unit employees may be granted approval to enroll at any CSU campus under the Faculty Fee Waiver Program for two (2) courses or six (6) units, whichever is greater, per term, excluding the doctoral program (Ed.D.). Units for the doctoral program are determined

California State University, Long Beach FACULTY FEE WAIVER ...

Eligibility and benefits depend upon service; must have a minimum of 90 aggregate days of active duty service to qualify. Service member or veteran will receive tuition and fee payment to school based on percentage eligibility, monthly housing allowance, and annual books/supplies stipend not to exceed \$1,000.00 per year.
