You don't need to complete a special form – just a letter explaining your request for audit reconsideration. Be clear about which changes you want the IRS to consider. You should provide: A copy of your audit report (IRS Form 4549, Income Tax Examination Changes), if available. Copies of the new documentation that supports your position.

To request reconsideration of your audit decision, you must write the appropriate Service Center with a list of the IRS changes disputed or simply call (800) 829-1040. Once the IRS has received your request for audit reconsideration, it will respond with a list of information needed from you in order to reconsider
